

**RELEASE OF LIABILITY AND ACKNOWLEDGMENT AND ACCEPTING OF  
DANGERS, RISKS AND HAZARDS**

I HEREBY ACKNOWLEDGE THAT I ("Campout Participant and/or Invitee) am willingly attending a Rifle/Shotgun Campout with Troop 124 on private lands ("Premises") owned by Dwight and Rebecca Shewchuk ("Land Owners").

I further acknowledge and understand that no warranty, either expressed or implied is made by Land Owners as to the conditions of the property or the safety of the Rifle /Shotgun Campout located in Collin County or any roads, buildings, gates, or other improvements located thereon. This document is sufficient warning that dangerous conditions, risks, and hazards do exist with this Rifle/Shotgun Campout as well as on the Premises where it is held. My presence and activities on the premises expose both me and/or my child and my property to dangerous conditions, risks, and hazards, including but not limited to, poisonous snakes, insects, and spiders; erosion and general condition of land, both on and off roadways or senderos, creating rough, hazardous and dangerous driving and walking conditions; animals both wild and domestic that may be diseased and or potentially dangerous; deep water; persons with firearms (including firearms that I use myself) on the premises; and the use of vehicles. I hereby state that I expressly assume all such dangers, risks and hazards.

In consideration for the right to enter the premises and take part in this Rifle/Shotgun Campout, I hereby release and agree to protect, indemnify and hold harmless the Land Owners and his or her respective agents, employees, invitees and assigns from and against all claims, demands, causes of action and damages, including attorney's fees resulting from any accident, incident, or occurrence arising out of incidental to or in any way resulting from the use of the premises, all improvements thereon, uses of firearms, whether or not caused by the Land Owners negligence or gross negligence. I hereby further covenant and agree that I, my parents, my guardian(s), my heirs, successors and assigns will not make claim or action of law or in equity against the Land Owner(s) or his or her respective heirs, agents, representatives, invitees, employees, successors or assigns.

As used in this release, the terms I, MY PERSON and MYSELF include Minors while on the Premises.
